Subject: Abolition of affidavits and promotion of self-certification - regarding.

All the FBOs applying for Product Approvals in the FSSAI are aware that they are required to submit an 'Affidavit' on Non-judicial Paper as part of documents in support their application.

- 2. Recognising the need for ease of business in this behalf, and in view of the order of the Government of India vide its O.M. No. Z.17015/1/2014-CDN-I dated 17th October, 2014 regarding the abolition of affidavits and promotion of self-certification, the Food Authority has decided to substitute the 'Affidavit' with an 'Undertaking by way of Self Declaration' to be submitted on a plain paper vide its order issued vide No.Z-16011/14/2014-E&A(Pt) dated 31st December, 2014.
- 3. Pursuant to the said decision, it is hereby informed that the 'Affidavit', as required to be submitted along with the application for Product Approval hitherto, is hereby substituted with an 'Undertaking' on a plain paper as per the format as enclosed.
- 4. Accordingly, the Food Business Operators applying for Product Approval are requested to enclose the Undertaking by way of self declaration as a replacement to the notarized Affidavit with immediate effect. The Product Approval Division will not accept the notarized affidavits after 1st March, 2015.
